The Kentucky Florists' Association is presenting its annual Kentucky Cup Contest - CHOPPED (inspired by Food Network's "Chopped"). This year you will see up to eight past Kentucky Designers of the Year compete in a live "Chopped" style completion on Saturday, August 4. This is sure to be an exciting competition and if you are a past Designer of the Year, we hope that you will consider entering this challenge.

**CONTEST RULES:** The Kentucky Cup Contest is open to any past winner of the Kentucky Florists' Association's Designer of the Year completion and who is a current KFA member. The first eight participants to register for the competition will be allowed to compete. The competition will take place on the main convention stage on Saturday, August 4 at 1:45PM. Each participant is required to provide their own set of tools limited to a floral knife, pruners, ribbon shears, wire cutters and needle nose pliers. All other materials and supplies will be provided in a surprise package by KFA. Each participant will then complete in a timed design challenge and present their final design(s) to a panel of judges. Each participant must be registered for the KFA Convention and is expected to attend the President's Gala on Saturday evening when the winner is announced.

**JUDGING:** Each design will be critiqued live, on-stage by a panel of judges. After the on-stage portion has concluded the judges will deliberate to determine the final winner. First, second, and third place winners will be announced at the Gala on Saturday evening.

**PRIZE:** First place winner will receive \$200 and a ribbon. Second and Third places will receive a ribbon.

**REGISTRATION:** Advance registration is required. No registration fee is required for this contest. Please complete the below form and mail it to Harriette Miller, 810 S. 7th St. Louisville, KY 40203. Registration form must be postmarked by July 27, 2018.
